



Terms and Conditions

Welcome to Biscle, the mobile app for business networking. The following Terms and Conditions govern your use of the Biscle app and any related services (the "Service"), which are operated by Biscle ("we" or "us"). By using the Service, you agree to be bound by these Terms and Conditions. If you do not agree to these Terms and Conditions, you may not use the Service.
